SCHOOL FEES FOR 2022

School fees for 2022 will be \$396.50 per term per family = \$1,586 yearly fee

School Fee - \$316.50 per term

Building Levy - \$80.00 per term

\$396.50 per term

Your 2022 Term 1 Account will show all payments relating to your child's school fees.

This will include, Subject Levies, Digital Technologies Levy, Excursion Levy, Term 1, 2, 3, & 4 Fees and Building Levies, School Camps, Swimming and the Maintenance Levy.

For concession card holders CSEF eligibility will be subject to the parent/legal guardian's concession card being successfully validated with Centrelink on the first day of either term one (28 January 2022) or term two (26 April 2022).

Accounts will be sent home at the beginning of each term and you need only pay term by term.

Digital Technologies Levy (*per child*) – payable in Term 1, and charged on Term 1 Account

Foundation to Year 6 - \$120

Excursion Levy (*per child*) - payable in Term 1, and charged on Term 1 account

Foundation to Year 6 - \$80

School Camp

Year 5 & 6 Camp - \$300 *(To be confirmed when negotiating camp costs)*

Swimming

Foundation to Year 6 - \$120 *(To be confirmed when negotiating with program in 2022)*

Maintenance Levy - **\$75.00**. This charge is an annual fee applied in Term 1 only, and will be removed if the family attends one of the scheduled Working Bees.

SUBJECT LEVIES : 2022

- **Per student levy:**
 - Foundation - Year 4 \$335
 - Year 5 & 6 \$370 *

Year levies cover costs in providing our learning programs –paper and copying, reading material including library books, Maths, P.E and music equipment, art materials, resources in each curriculum area and provision of and maintenance of Digital Technologies. This Subject Levy along with the Excursion Fee must be paid before 25th March, 2022.

*Year 5 & 6 students incur an increased subject levy to cover the Inter-School Sports Program and bus expenses. It is essential that all families meet their agreed obligations, as per enrolment conditions.

All families will be billed early February 2022 so it is imperative that if you envisage difficulties in paying 2022 Fees or Levies, you contact me prior to that date.

Fees & levies will be billed in full. The total amount may be paid in full, or as follows:

- **Total of Year levy amounts and Excursion Levy to be paid in full by 25th March, 2022**
- **The balance can be split and paid by the following dates – 4 March, 13 May, 12 August, 14 October.**

Should you need to arrange other forms of payment, such as monthly, fortnightly or weekly, please contact me. Preferred payment methods is by BPAY/Eftpos.

CAMPS, SPORTS AND EXCURSIONS FUND

CSEF ELIGIBILITY 2022

Below is the criteria used to determine a student's eligibility for the Camps, Sports and Excursions Fund (CSEF).

Criteria 1 – Eligibility

To be eligible* for the fund, a parent or legal guardian of a student attending a registered Government or non-government Victorian primary or secondary school must:

- on the first day of Term one, or;
- on the first day of Term two;
- a) Be an eligible beneficiary within the meaning of the *State Concessions Act 2004*, that is, be a holder of Veterans Affairs Gold Card or be an eligible Centrelink Health Care Card (HCC) or Pensioner Concession Card (PCC) holder, OR
- b) Be a temporary foster parent, and;
- c) Submit an application to the school by the due date.

* A special consideration eligibility category also exists. For more information, see: www.education.vic.gov.au/csef

Parents who receive a Carer Allowance on behalf of a child, or any other benefit or allowance not income tested by Centrelink, are not eligible for the CSEF unless they also comply with one of (a) or (b) above.

Criteria 2 - Be of school age and attend school in Victoria

School is compulsory for all Victorian children aged between six and 17 years of age inclusive.

For the purposes of CSEF, students may be eligible for assistance if they attend a Victorian registered primary or secondary school. Typically, these students are aged between five and 18 years inclusive.

CSEF is not payable to students attending pre-school, kindergarten, home schooled, or TAFE.

Eligibility Date

For concession card holders CSEF eligibility will be subject to the parent/legal guardian's concession card being successfully validated with Centrelink on the first day of either term one (28 January 2022) or term two (26 April 2022).

PAYMENT AMOUNTS

CSEF payment amount

The CSEF is an annual payment to the school to be used towards camps, sports and/or excursion expenses for the benefit of the eligible student.

- Primary school student rate: \$125 per year.
- Secondary school student rate: \$225 per year.

The CSEF is paid directly to your child's school and will be allocated by the school towards camps, sports and/or excursion costs for your child.

HOW TO COMPLETE THE APPLICATION FORM

NOTE: ALL SECTIONS MUST BE COMPLETED BY PARENT/LEGAL GUARDIAN

1. Complete the PARENT/LEGAL GUARDIAN DETAILS section.

Make sure that the Surname, First Name, and Customer Reference Number (CRN) details match those on your concession card. You will also need to provide your concession card to the school.

If you are claiming as a Foster Parent or a Veteran Affairs Pensioner, you will need to provide a copy of documentation confirming your status as a temporary Foster Parent or provide your Veterans Affairs Pensioner Gold card to the school.

2. Complete the STUDENT/S DETAILS section for students at this school.

3. Sign and date the form and return it to the school office as soon as possible. The CSEF program for 2022 closes on 24 June, 2022.

CSEF payments cannot be claimed retrospectively for prior years.
